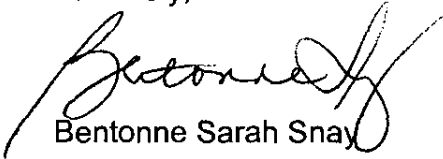
Re: No receipt of UBR prior notice.
