**ARTICLES OF INCORPORATION  
OF  
JIMMY DON'S HOPE, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME OF CORPORATION**

The name of this corporation is: Jimmy Don's Hope, Inc.

**ARTICLE II - ADDRESS OF REGISTERED & PRINCIPAL OFFICE**

**ARTICLE III - PURPOSES OF THE CORPORATION**

The purposes of the corporation are to produce, purchase, manufacture or otherwise acquire, sell, import, export, distribute and deal in plants and any related agricultural or horticultural materials of any kind and description.

The whole or any part of the capital stock of this corporation may be paid for in lawful money of the United States of America or in property, labor or services at a just valuation to be fixed by the Board of Directors.

**ARTICLE V - INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business shall be not less than Five Hundred Dollars (\$500.00).

**ARTICLE VI - TERM OF EXISTENCE**

The corporation is to exist perpetually.



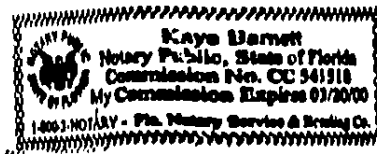
