# ARTICLE I.

#### Name

The name of this corporation is J. H. PETERS & ASSOCIATES, INC. The mailing address of the corporation is 1701 Starling Drive, Sarasota, Florida 34231.

#### ARTICLE II.

#### Term of Existence

The date when corporate existence shall commence shall be the date of subscription of these articles, and the corporation shall have perpetual existence thereafter.
