ARTICLES OF INCORPORATION
OF
JASMINE INVESTMENTS INC.

EFFECTIVE DATE
6-6-96

I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article 1. Name and Address. The name of the Corporation is Jasmine Investments Inc. The principal office and the mailing address of Jasmine Investments Inc. shall be located at 3174 Tamiami Trail East, Suite 1, Naples, Florida, 33962.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Effective Date. The effective date of the corporation, Jasmine Investments Inc., is June 6, 1996.

Article 5. Shares. The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares, consisting of one class only, designated as "Common Stock", of the par value of One dollar (\$1.00) per share.

Article 6. Initial Board of Directors. The number of directors constituting the Initial Board of Directors shall be one (1). The affairs of the corporation shall be managed by a Board of Directors whose qualifications and number shall be fixed by the Bylaws, but shall never be less than one. Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9. Right to Purchase Own Shares. The corporation shall have the right to acquire its own shares from time to time, upon such terms and conditions as the Board of Directors shall fix.

Article 10. Presumptive Rights. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article 11. Registered Office and Agent. The address of the initial registered office of the corporation is 3174 East Tamiami Trail, Suite #1, Naples, Florida, 33962, and the name of its initial registered agent at such address is Melinda P. Riddle.

Article 12. Indemnification. The Corporation shall indemnify to the full extent permitted by law any person who is made, or threatened to be made, a party to any action, suit or proceeding (whether civil, criminal, administrative or investigative) by reason of the fact that he/she is or was a Director, Officer, employee or agent of the Corporation or serves or served any other enterprise at the request of the Corporation.
