

# ARTICLES OF INCORPORATION OF



#### PLANET KARAOKE, INC.

#### Article I. Name and initial Address.

The name of the Corporation is PLANET KARAOKE, INC. with its initial business address being: 27221 Elaine Dr., Bonita Springs, Florida 33923 Article II. Duration.

The Corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles.

#### Article III. Purpose.

This corporation is organized for the purpose of transacting any and all lawful business as determined by its Directors.

#### Article IV. Capital Stock.

This corporation is authorized to issue Ten Thousand (10000) shares of capital stock, initially valued at one and no/100 dollars (\$1.00) per share of common stock.

#### Section 1 Dividends
