**ARTICLES OF INCORPORATION**

I, THE UNDERSIGNED, a natural person of legal age, acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

**ARTICLE ONE**

The name of the corporation is **TURF WORKS OF VOLUSIA COUNTY INC.**

**ARTICLE TWO**

The period of duration is perpetual.

**ARTICLE THREE**

The purpose for which the corporation is organized is to provide a landscaping and lawn service, including sprinkler installation and maintenance and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

**ARTICLE FOUR**

The aggregate number of shares which the corporation shall have authority to issue is **500** shares of common stock having no par value or amount of par value each.

**ARTICLE FIVE**

The corporation will not commence business until at least **FIVE HUNDRED DOLLARS (\$500.00)** have been received by it as consideration for the issuance of shares.

**ARTICLE SIX**

Provisions for the regulation of the internal affairs of the corporation are governed by the bylaws which shall be adopted by a majority of directors.

**ARTICLE SEVEN**

The address of the initial registered office of the corporation is 71 Brookwood Drive, Ormond

Beach, Florida, 32174 and the name of its initial registered agent at such address is **DANIEL P. CAVANAUGH**, who by his signature states that he is familiar with and accepts the duties and responsibilities as registered agent for this corporation.

#### **ARTICLE EIGHT**

#### **ARTICLE NINE**



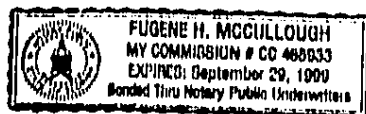
