ARTICLE I - NAME

The name of this corporation is SIGNATURE FLIGHT SUPPORT - NEW YORK,

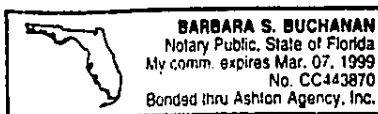
