**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation shall be Diefenbruch's Appraisal Service, Inc..

ARTICLE II - PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be 4054 Old Mill Cove Trail East, Jacksonville, Florida 32277.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these articles with the Department of State.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of performing all lawful business and for any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

ARTICLE VII - CUMULATIVE VOTING

At each election for directors every shareholder entitled to vote in the election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing the votes on the same principal among any number of the candidates.

ARTICLE VIII - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 4054 Old Mill Cove Trail East, Jacksonville, Florida 32277 and the name of this initial registered agent of this corporation at that address is Paul H. Diefenbruch III.

ARTICLE IX - INITIAL BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of the board of directors.

This corporation shall have one Director constituting the Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one director nor more than five. The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any bylaws adopted by the shareholders if the shareholders provide that the bylaws shall not be altered, amended or repealed by the board of directors.
