The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is SPK, INC. OF MT. DORA

ARTICLE TWO

ARTICLE THREE

CORPORATE DURATION

The duration of the Corporation is perpetual

ARTICLE FOUR

PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in buying, establishing, operating and selling any and all types of businesses which are lawful under the laws of the State of Florida.
2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceeding purposes.

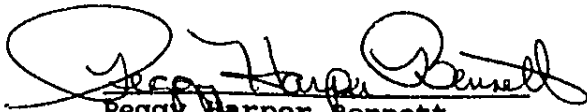
