# ARTICLES OF INCORPORATION

OF

### MAIN EXCHANGE, INC.

The undersigned, for the purpose of forming a corporation under Chapter 607, the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

### ARTICLE ONE

The name of the corporation is MAIN EXCHANGE, INC. and the corporate existence shall commence as of the date of the filing of these Articles of Incorporation.

The duration of the corporation is perpetual.
