ARTICLES OF INCORPORATION

OF

HIGH SANDS, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is HIGH SANDS, INCORPORATED.

ARTICLE II. NATURE OF CORPORATE BUSINESS

The corporation shall engage in the business of construction and construction related activity and any other activity or business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of share of stock this corporation is authorized to have outstanding at any time is Ten Thousand (10,000) shares of common stock, each share inaving a par value of One Dollar (\$1,00).

Authorized capital stock may be paid for in cash, services or property at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.
