Dear Sir / Madam,

I am writing this letter to advise you that I had never received your first mailing of the 2001 Uniform Business Report. Your past records will indicate that when I do receive your mailings as scheduled, I have always returned the information in a timely manner. Therefore, this is the first time anything like this has happened to me with any agency and I ask for your understanding, compassion and kindness in this matter.

I am a one person firm and therefore, personally receive all the mail myself. I swear to you that I never received the first report supposedly due back in May. The only copy of the 2001 Report I received was about a month ago (early August). I obviously recognized the Report's cover which in turn signified that it was that time of the year again to fill it out and mail in the fees. Its cover boldly stated that the Report is due by September 12, 2001 and thus, without opening it, I filed it away with my other bills to be paid in the first week of September. Upon opening the report for the first time on September 7, I was shocked and upset to see that the filing fee was \$550.00. However, I'm still left to wonder what happened to my Report. Whatever the circumstances, it still remains that I never received your original mailing!!!!

Since I was not made aware of the filing deadline due to someone else's error, how am I expected to pay the fees on time? As I mentioned, I am a small one person office struggling to make ends meet and have always been very responsible in filing all the necessary documents and fees when due. Likewise, I depend on each agency (post office included) to fulfill their obligations in getting me the necessary forms so that I can in turn comply with their requests. It is unfair for me to carry the heavy burden of paying such a high price for someone else's incompetence.

I ask you to please be reasonable in light of my timely filings and payments to you in the past. It is totally absurd to consider that I would knowingly miss the filing deadline with the realization that an extra \$400.00 would be due. Obviously, you should logically come to the conclusion that something outside of my control must have occurred. Furthermore, I ask you to please be compassionate enough to consider how long it takes someone to earn \$400.00. Then, please consider my extreme frustration, stress and anger over having to deal with this problem when it was never my fault to begin with. Please put yourself in my position and ask, "Why should I pay such a steep fine for someone else's mistake?" It certainly is not fair.

In closing, I would like to mention the fact that I did take the time to immediately call your office about this matter. I was able to speak to one of your representatives by the name of Suzanne on the telephone who kindly instructed me to send in the completed form along with a letter explaining the circumstances and the original payment of \$150.00. So, as you can see, it really was not my fault and I hope that your goodness and graciousness will allow you to accept my request.
