ARTICLES OF INCORPORATION
OF
SANDESPAN BUILDERS OF TAMPA, INC.

ARTICLE ONE

The name of the Corporation is Sandespan Builders of Tampa, Inc.

ARTICLE TWO

The period of its duration is perpetual.
