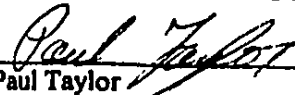
ARTICLES OF INCORPORATION
FOR

The undersigned incorporator, being a natural person of at least 18 years of age, states the following:

1. Name. The name of the corporation is Taylor Residential Construction, Inc..
2. Purpose. The purpose of the corporation is to engage in residential construction and to engage in any lawful business for which corporations may be organized under Florida law.
