The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation shall be:

**THOMAS R. MULCAHY, P.A.**

**ARTICLE II - TERM OF EXISTENCE**

The term of existence of the Corporation is perpetual.

**ARTICLE III - GENERAL PURPOSE**

This corporation is organized for the sole purpose of selling real estate.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the Corporation has authority to issue is 100, all of which shall be common stock with a \$1.00 per share par value.

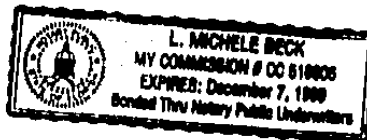
