



ARTICLES OF INCORPORATION - PROFESSIONAL ASSOCIATION

OF

ARTICLE I - NAME

The name of this Corporation is RONALD W. SLONAKER & ASSOCIATES, P.A.

ARTICLE II - DURATION

This Corporation/Professional Association shall have professional existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.


