

ARTICLES OF INCORPORATION OF

QUALITY HELP LINK, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is QUALITY HELP LINK, INC.

ARTICLE TWO

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 112 Durham Place, Longwood, Seminole County, Florida 32779-7116.

ARTICLE THREE

CORPORATE DURATION

The duration of the Corporation is perpetual.

ARTICLE FOUR

PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of generation of creative ideas and creative writing for itself and on behalf of other persons or entities seeking its assistance.
2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceeding business.

3. To engage in any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

4. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.
