ARTICLES OF INCORPORATION  
OF  
J & D TECHNOLOGY GROUP, INC.

The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is J & D Technology Group, Inc., 5810 Yahl St. #102, Naples, Fl. 33942.

ARTICLE II

GENERAL NATURE OF BUSINESS
