SECRETARY OF STATE ALLAHASSEE. FLORIDA THE UNDERSIGNED, acting as sole incorporator of ProVision Management, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office
