ARTICLE I - NAME

The name of this Corporation is Safeguard International, Inc. The mailing address is: 3620 Creekside Drive, Sebring, Florida 33872.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on June 12, 1996.

ARTICLE III - PURPOSE


