ARTICLES OF INCORPORATION OF HEARING CONCEPTS, INC.

The undersigned, acting as the incorporators of HEARING CONCEPTS, INC. TLORIDA under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION: The name of the Corporation is HEARING CONCEPTS, INC.

ARTICLE II - COMMENCEMENT OF EXISTENCE: The existence of the corporation will commence on the date of filing these Articles of Incorporation.

ARTICLE III - PURPOSE: This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV - AUTHORIZED SHARES: The maximum number of shares that the corporation is authorized to have outstanding at any time is one thousand (1,000) shares of common stock, each having a par value of one dollar (\$1.00) per share.
