OF

ARTICLE I - NAME

The name of this corporation is JTTD, INC.

ARTICLE II - PURPOSE

The corporation shall be authorized to transact all legal business of any nature.

The power to alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.


