ARTICLE I - NAME

The name of this corporation is JTTD, INC.

ARTICLE II - PURPOSE

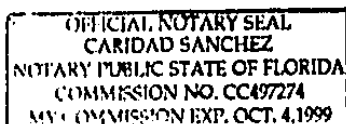


