**ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a professional association pursuant to Chapter 621 of the Florida Statutes.

ARTICLE I. CORPORATE NAME.

The name of this corporation is: Joan M. Mones, D.O., P.A.

ARTICLE II. PURPOSE AND NATURE OF BUSINESS.

The corporation will engage in the practice of medicine, medical research, and any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1 per share.

ARTICLE IV. TERM OF EXISTENCE.

This corporation shall have perpetual existence, commencing upon filing of these Articles.

ARTICLE X. SHAREHOLDER PROPERTY.

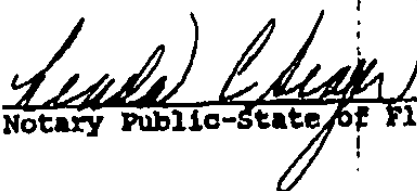

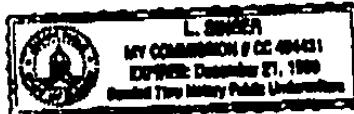
