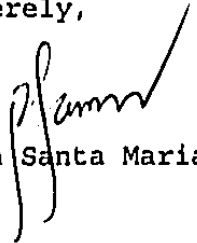

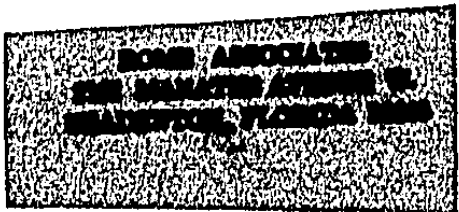

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Ramon Santa Maria, MD PA

ARTICLE II - DURATION

The Corporation shall have a perpetual existence unless dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in medical services of business permitted under the Laws of the United States and Florida. The corporation shall have power to do everything necessary, proper, advisable and convenient for the accomplishment of the purposes hereinafter set and to do all other things incidental thereto or connected therewith which are not prohibited by statute or by these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of One Dollar (\$1.00) per share, each of which shall have the same rights and privileges.

ARTICLE V - INITIAL REGISTERED
OFFICE AND AGENT

The initial principal and registered office of this Corporation shall be 1901 Haverford Road, Ste. 106, Sun City, FL 33573 and the initial registered agent of this Corporation at such office shall be Ramon Santa Maria, who, upon accepting this designation, agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial board of Directors shall consist of one member. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one (1) nor more than five (5). 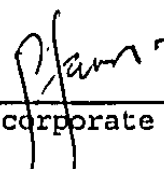

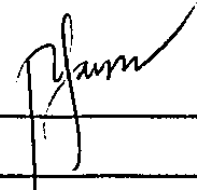
