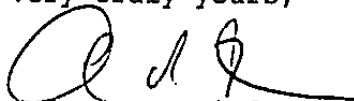

I, the undersigned, desiring to organize a professional service corporation for the purposes hereinafter stated, pursuant to the laws of the State of Florida, hereby certify as follows:

ARTICLE I

The name of the corporation shall be:

ARF & ASSOCIATES, P.A.

ARTICLE II

The general nature of the professional services to be rendered by this professional service corporation shall be as follows; to wit;

(a) To carry on, pursuant to the laws of the State of Florida, the professional services rendered by attorneys and to engage in all of its fields of specialization except that the corporation shall not render professional services except through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services within the State of Florida;

(b) To invest funds in real estate, mortgages, stocks and other types of investments; and

(c) To own real and personal property necessary to the rendering of the professional services hereby authorized.

ARTICLE III

The maximum number of shares of stock which this Corporation is authorized to have outstanding at any time and the class thereof is as follows: One Hundred Thousand (100,000) shares of Common Stock at a par value of One (\$1.00) Dollar.

ARTICLE IV

The amount of capital with which this corporation shall commence business shall not be less than Five Hundred Dollars (\$500.00).

ARTICLE V

This corporation shall have perpetual existence, unless dissolved according to law.

ARTICLE VI

The principal office of the Corporation shall be at: 5355 Town Center Road, Suite 801, Boca Raton, Florida 33486, and the registered agent at the above address is: ANDREW R. FRIEDMAN.

ARTICLE VII

No shareholder of this Corporation may sell or transfer his shares in this Corporation except to another individual who is licensed to render the same professional services which the Corporation has the power to conduct, and such sale or transfer may be made only after the same shall have been approved, at a stockholders meeting specially called for such purpose, by the holders of a majority of the outstanding stock. At such stockholder's meeting, the shares of stock held by the

shareholder proposing to sell or transfer his shares may not be counted or voted for any purpose. The Board of Directors of this Corporation may adopt any additional By-Laws restraining the alienation of shares; provided, however, that such provisions dealing with the purchase or redemption by the Corporation of its shares may not be invoked at a time or in a manner that would impair the capital of the Corporation.

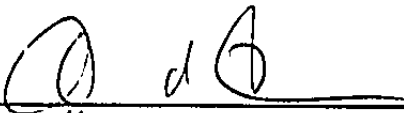

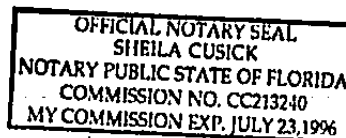
