ARTICLES OF INCORPORATION

OF

DAPPAUL, INC.

ARTICLE I. NAME

The name of the Corporation shall be: DAPPAUL, INC.

ARTICLE II. DURATION

As provided in Florida Statutes, Chapter 607, this Corporation shall exist in perpetuity.

ARTICLE III. PURPOSE

This Corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States and of this State.

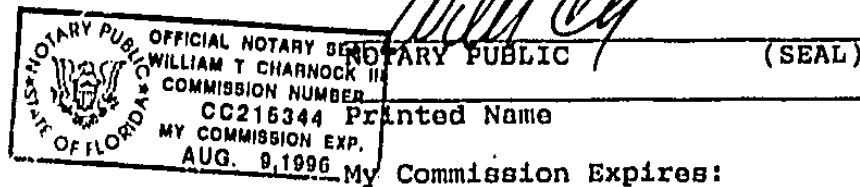
officers, employees and agents in their capacity as such, except for willful misconduct or gross negligence.
