ARTICLE I - NAME

The name of this corporation is ADDAM MASRI, M.D., P.A.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

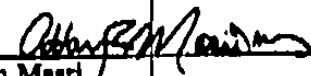
