

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE I**

Name

The name of the Corporation shall be Places Design, Inc.

**ARTICLE II**

Principal Office

The principal office and mailing address of the Corporation is located at 1320 N. Semoran Boulevard, Suite 104, Orlando, Florida 32807.

**ARTICLE III**

Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**

Duration of the Corporation

Existence of the Corporation shall commence on the later of the 14th day of June, 1996, or the date which is five (5) business days prior to the date these Articles of Incorporation have been filed by the Secretary of State and the Corporation shall exist perpetually unless dissolved according to law.

## ARTICLE V

### Authorized Stock

The total number of shares of capital stock which the Corporation has the authority to issue is 10,000 shares of Common Stock, with a \$1.00 par value per share.



Preemptive Rights


The shareholders of the Corporation shall have the preemptive right to acquire unissued or treasury shares of the Corporation as provided in Florida Statutes §607.0630.
