The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is BMC HOLDINGS, INC. whose principal place of business is One Financial Plaza, NationsBank Tower, Suite 1600, Ft. Lauderdale, Florida 33394

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State.

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of \$1.00 per share.


