ARTICLES OF INCORPORATION

OF

UNITY PICTURES, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: UNITY PICTURES, INC.
