FIRST: The name of the corporation is Agliano, Hodges & Whittemore, Inc. (the "Company").


SECOND: The shareholders of the company approved the dissolution of the Company on December 29, 1999.

THIRD: The number of votes cast by the shareholders of the Company for dissolution was sufficient for approval of that action.


FOURTH: The dissolution shall be effective at 11:59 P.M. on December 31, 1999.
