ARTICLE L. NAME

The name of this corporation shall be WATERMARK MARINE SERVICE, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles Of Incorporation by the State of Florida. This corporation's duration shall be perpetual.
