**ARTICLES OF INCORPORATION
OF**

ARTICLE I

The name of this corporation is

GOMEZ & GOMEZ GENERAL CONTRACTORS, INC.

ARTICLE II

The general nature of the business to be transacted by this Corporation is to engage in the business of building, remodeling and developing new and existing residential and commercial real property and any and all other businesses permitted under the laws of the State of Florida.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 7,500 shares of common stock having a par value of One Dollar (\$ 1.00) per share. 70% of stock to be held by Doris E. Gomez and 30% to be held by James H. Gomez.

ARTICLE V

The Registered Agent and the street address of the initial Registered Office of this Corporation in the State of Florida shall be:

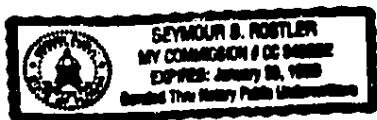
