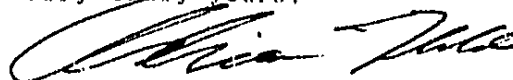

We, the undersigned, with other persons being desirous of forming a corporation under the provisions of Chapter 007 of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of the corporation shall be:

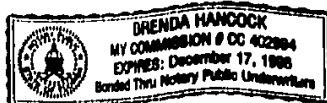
