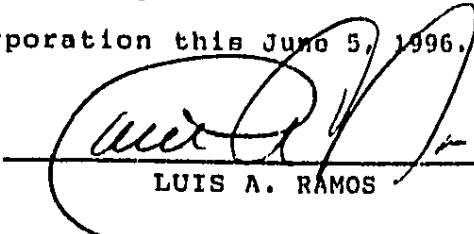
The power to adopt, alter, amend or repeal the Bylaws shall be

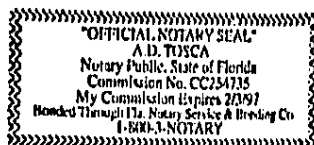
