ARTICLES OF INCORPORATION

OF.

WORLD WIDE WEB ASSOCIATION, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: WORLD WIDE WEB ASSOCIATION, INC. The address of the principal office of this corporation shall be 5999 Central Avenue, Suite 203, St. Petersburg, Florida 33710, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK
