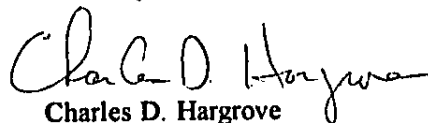

**ARTICLES OF INCORPORATION

The undersigned incorporator is forming a for-profit professional service corporation in accordance with Chapter 607 of the Florida Statutes and adopts the following articles of corporation.

**ARTICLE I
NAME**

The name of the professional service corporation is KIMBERLY G. ROBINSON, D.M.D., P.A.

**ARTICLE II
PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT**

**ARTICLE III
DURATION**
