ARTICLES OF INCORPORATION OF 5730 COLUMBIA CIRCLE, INC.

The undersigned hereby makes, subscribes, acknowledges, and files these Articles for the purpose of becoming a corporation under the Laws of the State of Florida.

Such offering shareholder shall deliver a notice in writing by mail or ۸. otherwise to the Secretary of the corporation stating the price, terms, and conditions of such proposed sale or transfer, the number shares to be sold or transferred, and his intention to so sell or transfer such shares.
