The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE - NAME

The name of the Corporation is International Museum Expositions, Inc. Its business location shall be 500 Winderley Place, Suite 215, Maitland, Florida 32751.
