The undersigned, desiring to form a professional corporation in accordance with the applicable provisions of Florida law, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation shall be:

CREATIVE SISTER PARTY PLANNER, INC.

ARTICLE TWO

PURPOSES

The purposes for which the corporation is organized are as follows:

(1) To engage primarily in the specific business of planning parties, weddings, and other festive occasions.

(2) To engage generally in the business of party planning as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;

(3) To engage in such other business as may be authorized or permitted under Florida law.

##### AMENDMENT

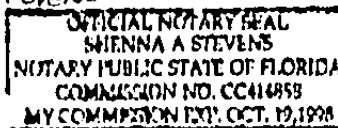
The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with applicable law.

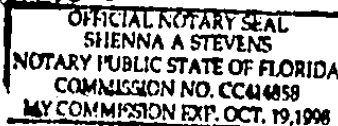
