The undersigned, acting as incorporator of FISOFT CORPORATION under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

# ARTICLE I. NAME

The name of the corporation is FISOFT CORPORATION

# ARTICLE II. ADDRESS

The mailing address of the corporation is 848 Brickell Ave., Miami, Florida 33131.

# ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on June 17, 1996.

# ARTICLE IV. PURPOSE
