# ARTICLES OF INCORPORATION

#### OF

# Assets Technologies, Inc. 1, the undersigned, being of legal age and a natural person, do, hereby subscribe to, acknowledge and file the following Articles of Incorporation for like purpose of creating a corporation under the laws of the State of Florida.

The name of this corporation shall be Assets Technologies, Inc. and the initial address of this corporation shall be c/o 741 S.E. 5th Place, Hialeah, Florida 33010.

# ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash or services.
