# ARTICLES OF INCORPORATION OF FLORIDA BAY CONSTRUCTION, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

## ARTICLE I - Name

The name of the corporation is **FLORIDA BAY CONSTRUCTION**, INC. The principal place of business of the corporation is 1160 8th Street South, Naples, Florida 34102. The mailing address of the corporation is 1160 8th Street South, Naples, Florida 34102.

# **ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

#### ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

# **ARTICLE IV - Stated Capital - Classes of Stock**

The corporation is authorized to issue 5000 shares of common stock at \$1,00 par value.

# **ARTICLE V - Special Provisions**

## ARTICLE X - Bylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors.

# **ARTICLE XI - Pre-emptive Rights**

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share at the price at which it is offered to others.

#### ARTICLE XII - Amendment
