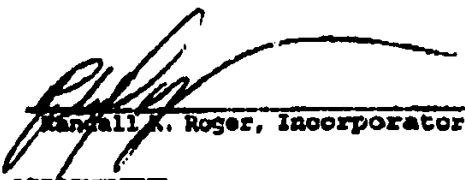
**ARTICLE VIII.
