#### ARTICLE I - NAME

The name of the corporation is Health Advantage Plus Inc.

#### ARTICLE II - DURATION

The right to transfer stock to a person not a stockholder shall not exist until all existing shareholders refuse the offer made as provided above or until they fail for a period of thirty (30) days after receipt of the written offer to accept the same by compliance with the terms therein set forth.
