**ARTICLES OF INCORPORATION
OF
KRAZEE TEES, INC.**

The undersigned, acting as the incorporator for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is **Krazee Tees, Inc.**

ARTICLE II - TERM OF EXISTENCE

The commencement date of this corporation shall be **June 12, 1996** and the period of duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

The purpose of the corporation is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 1000 shares, all of which shall be common shares at a par value of \$1.00 per share.

ARTICLE V - ADDRESS

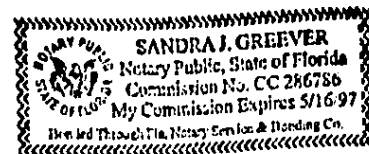
