# ARTICLES OF INCORPORATION COUNTY OF STREET

## GOLDRUSH DISC JOCKEYS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes and the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

Name

The name of this corporation is  $GOLDRUSH\ DISC\ JOCKEYS$ , INC.

#### ARTICLE II

Duration

The term of existence of this corporation is perpetual.

### ARTICLE III

#### Purpose

The corporation may transact any and all business for which corporations may lawfully be incorporated under the Florida Business Corporation Act.

#### ARTICLE IV

#### Capital Stock

The aggregate number of shares of stock which the corporation has the authority to issue is ONE HUNDRED (100) shares, all of which shall be common shares with a par value of ONE DOLLAR (\$1.00) each. Each shareholder of any class of stock of this corporation shall be entitled to full pre-emptive rights to purchase any unissued or treasury shares of the corporation, and any securities of the corporation convertible into, or carrying a right to subscribe to or acquire, shares of any such unissued or treasury shares.

#### Registered Office

#### ARTICLE VII

#### Directors
