ARTICLES OF INCORPORATION
OF
DODSON FAMILY CORPORATION

The undersigned associates for the purpose of becoming a corporation for profit under the laws of the State of Florida, and certifies that the following Articles of Incorporation have been adopted:

ARTICLE I

The name of the corporation is:

DODSON FAMILY CORPORATION

ARTICLE II

The principal place of business and mailing address of this corporation shall be 1037 Betton Road, Tallahassee, Florida 32312. This corporation shall commence its existence upon the signing and acknowledging of these Articles of Incorporation by the subscribing incorporators provided that these Articles of Incorporation are duly filed with the Secretary of State of the State of Florida.

ARTICLE III

The general nature of the business to be transacted by said corporation shall be and is, to engage in any and all lawful purposes, activity or business which corporations may be permitted under the laws of the United States and of the State of Florida; including, but not limited to all the general powers set forth in Section 607.0302, Florida Statutes.

ARTICLE IV

The maximum number of shares of common stock that this corporation is authorized to issue and to have outstanding at any time is 10,000 shares, having a par value of \$1.00 per share. All common stock shall be fully paid and non-assessable.

ARTICLE V

Every shareholder, upon the sale for cash of any new shares of stock of this corporation of the same kind, class, or series as that which she or he already holds, shall have the right to purchase her or his prorata share thereof (as nearly as may be done without issuance of fractional shares), at the price at which it is offered to others.

ARTICLES VI

The street address of the initial registered office of this corporation is:

ARTICLE VII

This corporation shall have two (2) Directors initially. The number of Directors may be increased from time to time by majority vote of the Shareholders. The names and street addresses of the initial Directors of this corporation, who, subject to the provisions of these Articles of Incorporation, the By-Laws of this corporation and the laws of the State of Florida, shall hold office

until the first annual meeting of shareholders and until their successors have been elected and qualified, or until their earlier resignations, removal from office or death, are as follows:

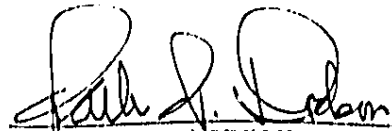
The proceeds of the shares of stock subscribed for will be at least as much as the amount of the par value thereof.

Incorporation, and certify that the facts herein stated are true.



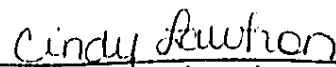

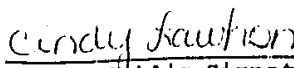
CERTIFICATE OF DESIGNATION AND

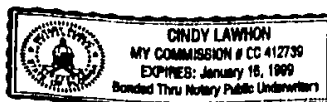
