ARTICLE VI - NATURE OF BUSINESS

The nature of the business or purporus to be conducted is to engage in or transact any or all landul activities or business permitted under he laws of the United States, the State of Florida or any other state, country or territory or nation.

ARTICLE VII - TERM OF EXISTENCE:

This corporation shall exist perpetually.

ARTICLE VIII - BYLAWS

The Bylaws of the Corporation may be adopted, altered, amended or repealed by either the Stockholder(s) or Director(s).

ARTICLE IX - DIRECTOR LIABILITY

No Director of the Corporation shall be personally liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except for liability (1) for any breach of a director's duty of loyalty to the Corporation or its stockholders (2) for acts or omissions not in good faith or which involve intentional miscounduct or a knowing violation of law, (3) under the provisions of the Florida General Corporation or (4) for any transaction from which the director derived an improper personal benefit.

ARTICLE X - INDEMNIFICATION

The Corporation shall indemnify any director, officer, or employed to the full extent permitted by law against all expense, liability and loss (including attorney's fees, judgments, fines, Employee Retirement Income Security Act of 1974, excise taxes or penalties and amounts paid or to be paid in settlement) reasonable incurred or suffered by such person in connection therwith and such indemnification shall continue as to a person who has ceased to be a director, officer, or employee or agent and shall inure to the benefit of his or her heirs, executors, and administrators; provided, however that the corporation shall indemnify any such person seeking indemnification in connection with a proceeding (or part thereof) initiated by such person only if such proceeding (or part thereof) initiated by such person was authorized bt the Board of Directors of the corporation.

ARTICLE XI - PREEMPTIVE RIGHTS

Each Stockholder of this Corporation shall have the first rights to purchase shares (and securities convertible into shares) of any, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized) including shares from the trasury of this corporation, in the ration that the number of shares he or she holds at the time of issue that the number of shares oustanding, exclusive of bears to the total number of shares oustanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not service it and pays for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him or her to exercise his or her preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
